

The olfactory emissions of the tested wall paint were examined and found to be marginal. Hedonic effects are undetectable. After a thorough inspection of the presented examination reports, voluntarily prepared safety data sheets following REACH standards and company data on the composition of possible emissions of substances during the proper use of the product, and particularly because of the omission of materials with high allergic potential and binding agents that could be harmful to one's health, the product is awarded the seal "Allergiker-freundlich" ("suited for allergy sufferers") of the IUG for two years. This also applies to a number of similar products disclosed to the IUG by AURO AG and listed in the annex.
